## SAUCIEST FOOTBALL PARTY OF THE YEAR WITH FRANK'S REDHOT® SAUCE RULES

THE SAUCEIST FOOTBALL PARTY OF THE YEAR WITH FRANK'S REDHOT® CONTEST (THE "CONTEST") IS INTENDED TO BE CONDUCTED IN THE PROVINCE OF ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF ONTARIO OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR IN PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

- **1. ELIGIBILITY.** To be eligible for this Contest, an individual must:
  - (a) be a legal resident of the province of Ontario;
  - (b) be of the age of majority or older at the time of entry;
  - (c) live within a forty-five (45) kilometer radius of the City of Toronto; and
  - (d) be able to accommodate fifteen (15) guests plus two (2) Station's employees at his/her place of residence on February 2, 2020 from approximately 6:00 p.m. ET to 10:00 p.m. ET.

**2. CONTEST PERIOD.** The Contest begins at 12:00 a.m. Eastern Time ("**ET**") on January 17, 2020 and ends at 12:00 p.m. ET on January 31, 2020 (the "**Contest Period**") after which time the Contest will be closed and no other entries shall be accepted.

### 3. HOW TO ENTER.

- (a) There is no purchase necessary to enter the Contest. Enter using the method of entry outlined below. No entries will be accepted by any other means.
  - (i) To enter online, complete and submit the entry form located at <a href="https://q107.com/contests/">https://q107.com/contests/</a> (the "Contest Website").
- (b) Limit of one (1) entry per household. In the case of multiple entries, only the first eligible

entry will be considered.

- (c) All entries become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- (d) Entries received online shall be deemed to be submitted by the authorized account holder of the e-mail address associated with the entry. #### 4. PRIZE.

- (a) **Prize.** There is one (1) prize ("**Prize**") available to be won by the Prize winner ("**Winner**") consisting of:
  - (i) A party hosted by the Station and Frank's RedHot® Sauce for the Winner and up to a maximum of fifteen (15) guests (the "Guests") to take place on February 2, 2020 from approximately 6:00 p.m. ET to 10:00 p.m. ET at the Winner's residence which shall include:
    - 1. Pizza for the Winner and Guests;
    - 2. One (1) smart TV to be selected by the Sponsor at its own discretion for the Winner; and
    - 3. Twenty Five (25) units of Frank's RedHot® sauce.
- (b) The Prize has an approximate value of One-Thousand Six-Hundred Canadian dollars (CDN \$1,600.00).
- (c) Winner is not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- (d) The Sponsors and/or the Sponsors' representatives will contact the Winner to coordinate the provision of the Prize within one (1) business day once such Winner has been successfully contacted and notified of his/her Prize and fulfilled the requirements set out herein.

## 5. PRIZE CONDITIONS.

(a) Winner and Guests will be responsible for all incidental costs and expenses not explicitly included in the Prize.

- (b) Guests must comply with the Contest Rules and sign and return the Release (described below).
- (c) Prize must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. Any unused, unclaimed or declined portion of a Prize will be forfeited, have no cash value and the Sponsors shall have no obligation to provide either an alternative or value-in-kind. The Sponsors reserve the right, in their sole discretion, to substitute a prize of equal or greater value if the Prize (or any portion thereof) cannot be awarded for any reason.

#### 6. WINNER SELECTION.

One (1) Winner shall be selected by the Station as follows:

- (a) On or about January 31, 2020 in Toronto, Ontario, one (1) entrant will be selected by a random draw from all eligible entries received during the Contest Period. Before being declared a Winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by email, to comply with the Contest Rules and sign and return the Release (described below).
- (b) The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsors.
- (c) THE SELECTED ENTRANT WILL BE NOTIFIED BY TELEPHONE OR E-MAIL NO LATER THAN JANUARY 31, 2020 AT 1:00 P.M. ET AND MUST RESPOND WITHIN ONE (1) HOUR OF NOTIFICATION. Upon notification, the selected entrant must respond by telephone or e-mail (as specified in the notification) to the contact number or e-mail address provided no later than the indicated deadline set out in the Contest Rules and/or the notification. If the selected entrant does not respond accordingly, he/she will be disqualified and will not receive a Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.
- (d) If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.

The Sponsors assume no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including those reasons beyond the control of the Sponsors, such as infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest and/or the Contest Website.

- **TERMINATION.** The Sponsors reserve the right, in their sole discretion, to terminate the Contest, in whole or in part, and/or modify, amend or suspend the Contest, and/or the Contest Rules in any way, at any time, for any reason without prior notice.
- 14. LAW. These are the official Contest Rules. The Contest is subject to applicable federal, provincial and municipal laws and regulations. The Contest Rules are subject to change without notice in order to comply with any applicable federal, provincial and municipal laws or the policy of any other entity having jurisdiction over the Sponsors.
