FREE PIZZA FOR A YEAR RULES

THE COUNTRY 104 FREE PIZZA FOR A YEAR CONTEST (THE "CONTEST") IS INTENDED TO BE CONDUCTED IN THE PROVINCE OF ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF ONTARIO OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR IN PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

- 1. **ELIGIBILITY.** To be eligible for this Contest, an individual must:
 - (a) be a legal resident of the province of Ontario; and
 - (b) be of the age of majority or older at the time of entry.

Employees of Corus Radio Inc. operating CKDK-FM (the "Station") and its parents, affiliates, subsidiaries, related companies, successors and assigns (together with the Station, "Corus"), Chairman's Brands Corporation, and its affiliates, subsidiaries, related companies, successors and assigns (collectively, "Chairman's Brand Corporation" and together with Corus, the "Sponsors"), advertising and promotional agencies, and/or the household members of any of the above are not eligible to enter.

The Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsors for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

2. CONTEST PERIOD. The Contest begins at 12:00 a.m. Eastern Time ("ET") on January 6, 2020 and ends at 11:59 p.m. ET on February 2, 2020 (the "Contest Period") after which time the Contest will be closed and no other entries shall be accepted.

3. HOW TO ENTER.

- (a) There is no purchase necessary to enter the Contest. Enter using the method of entry outlined below. No entries will be accepted by any other means.
 - (i) To enter online, complete and submit the entry form located at https://country104.com/ (the "Contest Website").
- (b) Limit of one (1) entry during the Contest Period. In the case of multiple entries, only the first eligible entry will be considered.
- (c) All entries become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.

(d) Entries received online shall be deemed to be submitted by the authorized account holder of the e-mail address associated with the entry. For the purpose of the Contest Rules, "authorized account holder" of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Any entrant may be required to provide the Sponsors with proof that they are the authorized account holder of the e-mail address associated with their entry.

4. PRIZES

- (a) **Grand Prize.** There is one (1) grand prize ("**Grand Prize**") available to be won by the Prize winner ("**Grand Prize Winner**") consisting of:
 - (i) Twelve (12) New Orleans Pizza gift cards each in the amount of Fifty Canadian dollar (CDN\$50.00).
- (b) The Grand Prize has an approximate value of Six Hundred Canadian dollars (CDN \$600.00).
- (c) **Secondary Prizes.** There are four (4) secondary prizes (each, a "**Secondary Prize**") available to be won by the Secondary Prize winners (the "**Secondary Prize Winners**"), which consists of: one (1) New Orleans Pizza gift card in the amount of Twenty-Five Canadian dollars (CDN \$25.00).
- (d) Grand Prize and Secondary Prizes are hereafter collectively referred to as "**Prize**" or "**Prizes**". Grand Prize Winner and Secondary Prize Winners are hereafter collectively referred to as a "**Winner**" or "**Winners**".
- (e) Winners are not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- (f) Winners may claim Prizes at the Station studios in London, Ontario within five (5) business days once each Winner has been successfully contacted and notified of his/her Prize and fulfilled the requirements set out herein.

5. PRIZE CONDITIONS.

- (a) Winners will be responsible for all incidental costs and expenses not explicitly included in the Prize, including without limitation, delivery costs, gratuities, any cost beyond the value of the gift card, and any other expense not explicitly included in the Prize.
- (b) The terms by which the gift cards may be redeemed are governed by the individual retailer or service provider. Corus is not responsible for administering or ensuring compliance with the terms and conditions relating to the gift cards.
- (c) Prizes must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. - (a) On each of January 10, 2020, January 17, 2020, January 24, 2020, and January 31, 2020 in London, Ontario, one (1) entrant will be selected by a random draw from all eligible entries received during the Contest Period as a potential Secondary Prize Winner.
- (b) On or about February 3, 2020 in London, Ontario, one (1) entrant will be selected by a random draw from all eligible entries received during the Contest Period as the potential Grand Prize Winner.
- (c) Before being declared a Winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail, to comply with the Contest Rules and sign and return the Release (described below).
- (d) The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsors.

If the selected entrant does not respond accordingly, he/she will be disqualified and will not receive a Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.

The Sponsors assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries. The Sponsors assume no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including those reasons beyond the control of the Sponsors, such as: infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest: and/or the Contest Website.

All rights are reserved. Unauthorized copying or use of any copyrighted material or intellectual property without the express written consent of its owner is strictly prohibited.
- **TERMINATION.** The Sponsors reserve the right, in their sole discretion, to terminate the Contest, in whole or in part, and/or modify, amend or suspend the Contest, and/or the Contest Rules in any way, at any time, for any reason without prior notice.
- 14. LAW. These are the official Contest Rules. The Contest is subject to applicable federal, provincial and municipal laws and regulations. The Contest Rules are subject to change without notice in order to comply with any applicable federal, provincial and municipal laws or the policy of any other entity having jurisdiction over the Sponsors. All issues and questions concerning the construction, validity, interpretation and enforceability of the Contest Rules or the rights and obligations as between the entrant and the Sponsors in connection with the Contest shall be governed by and construed in accordance with the laws of the province of Ontario without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws.
