#### **DAVECATION GETAWAY RULES**

THE DAVECATION GETAWAY CONTEST (THE "**CONTEST**") IS INTENDED TO BE CONDUCTED IN THE PROVINCE OF ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF ONTARIO OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR IN PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "**CONTEST RULES**").

- 1. **ELIGIBILITY.** To be eligible for this Contest, an individual must:
  - (a) be a legal resident of the province of Ontario;
  - (b) be of the age of majority or older at the time of entry;
  - (c) be legally able to travel to Mexico, and have any and all necessary documentation as may be required for presentation to Canadian and/or International customs and airport personnel; and
  - (d) live within one hundred (100) kilometer radius of the City of Kitchener.

Employees of Corus Radio Inc. operating CJDV-FM (the "Station") and its parents, affiliates, subsidiaries, related companies, successors and assigns (together with the Station, the "Sponsors"), and Sunwing Vacations Inc. its affiliates, subsidiaries, related companies, successors and assigns (the "Prize Provider"), advertising and promotional agencies, any person who has been confirmed as a winner of any previous Station administered contests within sixty (60) days preceding the Contest start date indicated below where the prize was valued over One Thousand Canadian dollars (CDN\$1,000.00), and/or the household members of any of the above are not eligible to enter.

The Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. 2. CONTEST PERIOD. The Contest begins at 12:01 a.m. Eastern Time ("ET") on November 4, 2019 and ends at 11:59 p.m. ET on December 15, 2019 (the "Contest Period") after which time the Contest will be closed and no other entries shall be accepted.

### **3.** HOW TO ENTER.

- (a) There is no purchase necessary to enter the Contest. Enter using the method of entry outlined below. No entries will be accepted by any other means.
  - (i) Listen to the Station Monday to Sunday during the Contest Period for the Davecation Jet sound effect to be played (the "Cue"). Upon hearing the Cue, listeners are invited to email the Station at <u>sunwing@1075daverocks.com</u> including full name, address, date of birth, telephone and email address to qualify

to enter the prize draw.

- (b) Unlimited entries during the Contest Period.
- (c) All entries become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- (d) Entries received shall be deemed to be submitted by the authorized account holder of the e-mail address associated with the entry. - (a) **Prizes.** There are three (3) prizes ("**Prizes**"; each a "**Prize**") available to be won by the Prize winners ("**Winners**"; each, a "**Winner**") consisting:
  - (i) A trip for two (2) to Cancun, Mexico (the "**Destination**") which shall include:

Should Winners and/or Guests be unable to travel on the dates and times designated by the Sponsor, the Prize will be forfeited and awarded to an alternate winner.

(f) The Sponsors shall not assume any liability for lost, damaged or misdirected Prizes.

### 6. WINNER SELECTION.

Three (3) Winners shall be selected by the Sponsors as follows:

- (a) On each of November 18, December 2, and December 16, 2019 in Kitchener, Ontario, one (1) entrant will be selected by a random draw from all eligible entries received during the Contest Period. Each entrant shall be eligible to win only one (1) Prize. Before being declared a Winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail, to comply with the Contest Rules and sign and return the Release (described below).

If the selected entrant does not respond accordingly, he/she will be disqualified and will not receive a Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.

Each entrant agrees to fully indemnify Releasees from any and all claims by third parties relating to the entrant's participation in the Contest, without limitation.
