### CFOX HOLY GUACAMOLE FLYAWAY RULES

CFOX HOLY GUACAMOLE FLYAWAY CONTEST (THE "CONTEST") IS INTENDED TO BE CONDUCTED IN THE PROVINCE OF BRITISH COLUMBIA ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF BRITISH COLUMBIA OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR IN PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

- **1. ELIGIBILITY.** To be eligible for this Contest, an individual must:
  - (a) be a legal resident of the province of British Columbia;
  - (b) be of the age of majority or older in the province of British Columbia at the time of entry; and
  - (c) be legally able to travel to Mexico and have any and all necessary documentation as may be required for presentation to Canadian and/or International customs and airport personnel.

Employees of Corus Radio Inc. operating CFOX-FM (the "Station") and its parents, affiliates, subsidiaries, related companies, successors and assigns (together with the Station, the "Sponsors"), Sunwing Vacations Inc. and its affiliates, subsidiaries, related companies, successors and assigns (collectively, the "Prize Provider"), advertising and promotional agencies, any person who has been confirmed as a winner of any previous Station administered contests within thirty (30) days, and/or the household members of any of the above are not eligible to enter.

The Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsors for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. 2. **CONTEST PERIOD.** The Contest begins at 6:00 a.m. Pacific Time ("**PT**") on July 3, 2018 and ends at 6:00 p.m. PT on July 27, 2018 (the "**Contest Period**") after which time the Contest will be closed and no other entries shall be accepted.

# 3. HOW TO ENTER.

- (a) There is no purchase necessary to enter the Contest. Enter using the method of entry outlined below. No entries will be accepted by any other means.
  - (i) Listen to the Station Monday to Friday during the Contest Period between 6:00 a.m. and 6:00 p.m. PT for the Contest cue to call to be played (the "Cue to Call"). Upon hearing the Cue to Call, listeners are invited to call 604-280-2369 (the "Contest Line"). The ninth (9th) caller through the Contest Line will qualify to enter the prize draw (each a "Qualifier"). There will be two (2) Cues to Call daily.

- (b) Limit of one (1) entry per household per week during the Contest Period. In the case of multiple entries, only the first eligible entry will be considered.
- (c) All entries become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- (d) Streaming listeners may be listening to a delayed stream of the radio signal, which may vary depending on the device on which you are listening and the speed of the internet connection. Sponsors recommend turning on a radio to the Station for the Cue to Call. Sponsors assume no liability for entrants not making timely phone calls to the Station due to delays in the streamed signal.
- (e) If the telephone connection between the Station announcer and an entrant is not clear, such that the announcer and/or entrant cannot hear each other or the entrant is disconnected, that entrant may, in the sole discretion of the Sponsors, be disqualified and the Releasees (defined below) will not be liable in any way.

#### 4. PRIZES.

- (a) **Prizes.** There are two (2) prizes ("**Prizes**" each a "**Prize**") available to be won by the Prize winners ("**Winners**" each, a "**Winner**") consisting of:
  - (i) A trip for two (2) to Cancun, Mexico (the "**Destination**") which shall include:
    - 1. Round-trip economy airfare onboard Sunwing Airlines for the Winner and his/her guest (the "Guest") leaving together from the same gateway, on the same itinerary, from Vancouver International Airport to the Destination:
    - 2. Ground transportation for the Winner and Guest between the airport and hotel in the Destination;
    - 3. Seven (7) nights all-inclusive hotel accommodation at the Royalton Riviera Cancun Resort OR Hideaway at Royalton Riviera Cancun to be selected by the Sponsors in their sole discretion for the Winner and Guest based on double occupancy unless otherwise indicated; and

- (c) Winners are not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.

(a) Prizes will be distributed within fourteen (14) business days after each Winner has been successfully contacted and notified of his/her Prize and fulfilled the requirements set out herein.

### 5. PRIZE CONDITIONS.

Should Winner and/or Guest be unable to travel on the dates and times designated by the Sponsors, the Prize will be forfeited and awarded to an alternate winner. Once the reservation is made, it cannot be changed. - (b) Passports must be valid for six (6) months beyond the departure date.

### 6. WINNER SELECTION.

Two (2) Winners shall be selected as follows:

(a) On each of July 16 and July 30, 2018 in Vancouver British Columbia, one (1) Qualifier

will be selected by a random draw from all eligible entries received by 6:00 p.m. PT on the Friday immediately preceding the draw date. **Entries do not rollover to subsequent draws**. Each entrant shall be eligible to win only one (1) Prize. Before being declared a Winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered at Station's studios to comply with the Contest Rules and sign and return the Release (described below).

(b) The odds of being selected as a potential Qualifier are dependent upon the total number of people who call the Contest Line during a Cue to Call. Once a Qualifier, the odds of being selected as a potential winner are as follows:

If the selected entrant does not respond accordingly, he/she will be disqualified and will not receive a Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.
- (d) If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.

Each entrant further agrees to be bound by the decisions of the Sponsors, which shall be final and binding in all respects. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant found to be: (a) violating the Contest Rules; (b) tampering or attempting to tamper with the entry process or the operation of the Contest, the Contest Website or any related promotional website; (c) violating the terms of service, conditions of use and/or general rules or guidelines of any Sponsors' property or service; and/or (d) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass the Sponsors or any other person. - **TERMINATION.** Sponsors reserve the right, in their sole discretion, to terminate the Contest, in whole or in part, and/or modify, amend or suspend the Contest, and/or the Contest Rules in any way, at any time, for any reason without prior notice.
