WHERE IN THE WORLD IS MR. FOX RULES

THE WHERE IN THE WORLD IS MR. FOX CONTEST (THE "CONTEST") IS INTENDED TO BE CONDUCTED IN THE PROVINCE OF BRITISH COLUMBIA ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE TWENTY-ONE YEARS OF AGE OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR IN PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

- 1. **ELIGIBILITY.** To be eligible for this Contest, an individual must:

 - Listen to the Station Monday to Friday (excluding statutory holidays) during the Contest Period at approximately 7:00 a.m. PT for the clue to the whereabouts of Mr. Fox to be announced (the "Clues").

Listen to the Station Monday to Friday (excluding statutory holidays) during the Contest Period between 7:00 a.m. and 6:00 p.m. PT for the Contest cue to call to be played (the "**Cue to Call**"). Upon hearing the Cue to Call, listeners are invited to call 604-280-2369 (the "**Contest Line**"). The ninth (9th) caller through the Contest Line has the opportunity to guess the exact location of Mr. Fox whereabouts (the "**Location**"). The selected caller who correctly identifies the exact Location will qualify to win a Prize to the Location for the period as outlined in section 4(a).  - 1. Round-trip economy airfare for the Grand Prize Winner and his/her Guest leaving together from the same gateway, on the same itinerary, from a major Canadian airport located near the Grand Prize Winner's home, as determined by the Sponsors in their sole discretion, to the destination city;
 - 2. Ground transportation for the Grand Prize Winner and Guest between the airport and hotel/ hotel and concert in the destination city;
 - 3. Four (4) nights standard hotel accommodation at a hotel to be selected by the Sponsors in their sole discretion for the Grand Prize Winner and Guest based on double occupancy unless otherwise indicated;

 - 6. Five Hundred Canadian dollars (CDN\$500.00) spending cash; and

- 7. This Grand Prize has an approximate value of Four Thousand Nine Hundred Canadian dollars (CDN \$4,900.00).
- (a) **Qualifying Prizes.** There are at least one hundred seventy four (174) qualifying prizes (each, a "**Qualifying Prize**") available to be won by the Qualifying Prize winners (the "**Qualifying Prize Winners**"), which consists of one (1) Station vintage T-shirt.
- (b) Each Qualifying Prize has an approximate retail value of fifteen Canadian dollars (CDN \$15.00).
- (b) Winners are not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- (c) Winners will be contacted by the Station's representatives to coordinate the provision of the Prizes within three (3) business days once such each Winner has been successfully contacted and notified of his/her Prize and fulfilled the requirements set out herein.

5. PRIZE CONDITIONS.

All rights are reserved. Unauthorized copying or use of any copyrighted material or intellectual property without the express written consent of its owner is strictly prohibited.
- **13. TERMINATION.** The Sponsors reserve the right, in their sole discretion, to terminate the Contest, in whole or in part, and/or modify, amend or suspend the Contest, and/or the Contest Rules in any way, at any time, for any reason without prior notice.
- 14. LAW. These are the official Contest Rules. The Contest is subject to applicable federal, provincial and municipal laws and regulations. The Contest Rules are subject to change without notice in order to comply with any applicable federal, provincial and municipal laws or the policy of any other entity having jurisdiction over the Sponsors. All issues and questions concerning the construction, validity, interpretation and enforceability of the Contest Rules or the rights and obligations as between the entrant and the Sponsors in connection with the Contest shall be governed by and construed in accordance with the laws of the province of Ontario without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws.
