FRESH –THE NEXT BEST THING TO CHEERLEADERS SHOWING UP AT YOUR HOUSE WITH POM POMS RULES

THE FRESH –THE NEXT BEST THING TO CHEERLEADERS SHOWING UP AT YOUR HOUSE WITH POM POMS CONTEST (THE "**CONTEST**") IS INTENDED TO BE CONDUCTED IN THE PROVINCE OF ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW.
