## 95.1 THE PEAK'S FRONT STEP SELFIE CONTEST RULES

THE 95.1 THE PEAK'S FRONT STEP SELFIE CONTEST (THE "CONTEST") IS INTENDED TO BE CONDUCTED IN THE PROVINCE OF ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF ONTARIO OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR IN PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

- 1. ELIGIBILITY. To be eligible for this Contest, an individual must:
  - (a) be a legal resident of the province of Ontario;
  - (b) be of the age of majority or older at the time of entry;
  - (c) be the sole owner of all right, title and interest (including copyright) in and to the Work (as defined below) submitted in connection with the Contest;
  - (d) be a homeowner of a residential property within a fifty (50) kilometer radius of the Town of Collingwood;
  - (e) have a valid Facebook account during Contest Period; and
  - (f) be willing and able to accept the Prize as awarded.

## **3.** HOW TO ENTER.

- (a) There is no purchase necessary to enter the Contest. Enter using the method of entry outlined below. No entries will be accepted by any other means.
  - (i) To enter upload a photo of yourself or with your household members together with a short paragraph describing why you want to win the Contest (the "**Work**") on your

Facebook account, and tag 95.1 The Peak @95.1thepeakfm. <u>Do not include street</u> names or residence's street numbers in your picture.

ENTRANTS WHO SUBMIT THE WORK REPRESENT THAT THEY HAVE OBTAINED OR WILL OBTAIN THE RIGHT TO USE THE NAME AND OTHER LIKENESS OF THE PARTICIPANTS IN CONNECTION WITH THE WORK AND THE CONTEST AND FOR THE PURPOSES STATED HEREIN.

- (b) By participating in this Contest, each entrant represents and warrants that the Work: (i) does not contain any material, language or gestures that are libelous, defamatory, indecent, profane, obscene or violent and does not violate any laws relating to hate speech or otherwise; (ii) is original, solely created by the entrant and that no third party participated as an author, co-author or otherwise in the creation of the Work or any part thereof, and all right, title and interest (including copyright) therein is owned and/or controlled by the entrant to the full extent necessary to enable the Sponsors to use the Work as contemplated by these Contest Rules; (iii) does not infringe upon the intellectual property right, proprietary interest or other statutory or common law rights of any third party; (iv) does not contain any recognizable logos or any other copyrighted material; (v) does not contain any mention, endorsement, or "plug" any commercial product, service, venture or thing, including, without limitation, the name of your employer; and (vi) has not been submitted in connection with any other contest and/or promotional campaign.
- (c) Limit of one (1) entry per household during the Contest Period. In the case of multiple entries, only the first eligible entry will be considered.
- (d) All entries including the Work, become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. - (b) Winner is not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.

(c) The Sponsors and/or the Sponsors' representatives will contact the Winner to coordinate the provision of the Prize within five (5) business days once such Winner has been successfully contacted and notified of his/her Prize and fulfilled the requirements set out herein.

# 5. PRIZE CONDITIONS.

- (a) Winner will be responsible for all incidental costs and expenses not explicitly included in the Prize, including without limitation, costs above the value of the gift certificate, maintenance, any incidental or additional work or labour services, upgrades, any permits, licenses or other authorizations required (including any of their associated costs, taxes, accessories or items of a personal nature) and any other expense not explicitly included in the Prize.
- (b) Without limiting the generality of Section 5 (a), the Releasees, as defined below, are not responsible for any costs or fees associated with any hidden or unforeseen work required or recommended that is discovered in the redemption of the Prize or Prize elements (the "Hidden or Unforeseen Work"). # 6. WINNER SELECTION.

- (a) On or about June 1, 2020 in Collingwood, Ontario, one (1) entrant will be selected by a random draw from all eligible entries received during the Contest Period. Before being declared a Winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail, to comply with the Contest Rules and sign and return the Release (described below).
- (b) The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsors.
- (c) THE SELECTED ENTRANT WILL BE NOTIFIED BY DIRECT MESSAGE NO

LATER THAN JUNE 2, 2020 AT 5:00 P.M. ET AND MUST RESPOND WITHIN TWO (2) BUSINESS DAYS OF NOTIFICATION. If the selected entrant does not respond accordingly, he/she will be disqualified and will not receive a Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.
